## **Speaker Biographies**

#### Prof. Dr. Sarianna Lundan

Prof. Lundan focused her work on the interplay between governments, regulatory standards and multinational enterprises. Earlier on, she did some work on trade and commercial policy, as well as foreign direct investment in Japan, and Japanese investment abroad. She has been working on reinvested earnings as a component of FDI, and the role of taxation as a determinant of affiliate re-investment.

Her work has appeared in journals such as the Journal of International Business Studies, Industrial and Corporate Change, International Business Review, Asia Pacific Journal of Management, World Economy, and Transnational Corporations, and in numerous contributions to edited volumes. She is the editor or co-editor of four books, and together with the late John H. Dunning, co-author of the second edition of Multinational Enterprises and the Global Economy, a seminal book in the field of International Business.

## Dr. Lena Steinmann

During her research, Lena Steinmann pursued an interdisciplinary approach by applying geophysical methods to a variety of research areas. Her work included the acquisition of geophysical data during the scientific expedition, customized data preparation and analysis, and teaching these topics in university lectures.

As coordinator of the DSC, Lena Steinmann promotes interdisciplinary cooperation in the field of data science. She is responsible for establishing the scientific network and developing new collaborations. She coordinates the activities of the DSC including third-party funding, science communication, and public relations.
