That's why this media system becomes a kind of polygon for studying social movements and media system transformation.

Then we will focus on the different types of Ukrainian traditional and social media, on the dynamics of the information flows in this system, on external ties of this system, on the national and strategic narratives, on the state of 'affective public' during the important events.
