#### 3. With this application, I declare the following:

- a. The above changes reflect my wishes.
- b. The desired gender information and / or the desired first name(s) will be used and listed on all documents in the University of Bremen's campus management system (e.g. semester ticket, certificates of examination, degree certificates) and on the teaching / learning platform currently in use (currently Stud.IP). This means that the original name(s) and / or gender entry will be replaced by the name(s) or gender information chosen with this application.
- c. I am aware that I may be required to present a legal identification document (e.g. ID card, passport) in the event of identity checks and in cases where there is a legal obligation to identify myself (e.g. police checks, opening and management of a bank account).
- d. I am aware that a photo ID document (e.g. passport / ID card) is generally required for ticket inspections in connection with the semester ticket.
- e. I am aware that in the above-mentioned situations I may have to explain any discrepancy between the documents myself<sup>3</sup>.
- f. I am aware that my amended name data will be automatically transmitted to my health insurance company by the campus management system in the event of a change of status (i.e. withdrawal from degree).
- g. I have taken note that this application / declaration must be included in my electronic student file in the campus management system as long as no official proof of a change of status (court order or proof from the registry office) is available, as the information in the campus management system can be used for identification / traceability in legitimate cases of identity verification requests, e.g. in the case of police identity verification. Any other disclosure of the application data is excluded.
- h. If an official change of name(s) and / or status is intended, I will provide this information to the Student
  Office with appropriate proof (court order or proof from the registry office) after the official change of name(s) and / or status has been completed, so that any links to the old name that may exist can be deleted.
- i. With my signature, the University of Bremen is released from all claims that could arise due to the chosen new (first) name(s), the chosen gender entry, and the use of corresponding documents.

## With my signature, I hereby confirm that the above changes have been carefully considered, are in accordance with my wishes, and that the information I have provided is correct and binding.

<sup>3</sup> The confirmation letter from the Student Office, which you will receive after successfully applying to change your first name(s) and / or gender entry, can be helpful. The supplementary ID card from the German Society for Transidentity and Intersexuality (dgti) is also an additional aid.

Consent can be revoked at any time and the withdrawal of consent will not affect the lawfulness of processing based on prior consent before the time of with-drawal. I am aware that if I withdraw my consent to data processing, the application to change my first name(s) and / or gender entry must also be revoked.
