Information on the application for participation as a visiting student

1. The University of Bremen may admit students from other universities in Bremen to individual courses as visiting students for the duration of a semester, provided that this does not interfere with the studies of regular students and participation in the cours(es) is necessary or useful for the applicant's studies.

The reasons why participation in the event is necessary or expedient must be justified in the application.

Students from other universities may be admitted in justified exceptional cases.

Enrollment as a visiting student does not take place. Visiting students have the same rights and obligations as regular students of the University of Bremen with regard to the Courses to which they are admitted.

2. The following **application for participation as a visiting student** must be submitted for the application.

The application must list the events in which the applicants wish to participate with all the required information.

3. The applicant must obtain the consent of the university lecturers organising the individual courses.

In individual areas, the teaching representative / faculty must also be involved.

The application must be submitted **in person or by post** to the Student Office together with the declarations of consent from the teaching staff. The deadline for the summer semester is 30 April and for the winter semester 31 October.

4. Applicants will be issued with an attestation of secondary affiliation upon submission of the complete application, accompanied by the organisers' declarations of consent.
